JEWELRY STANDARDS: All Jewelry work will be subject to museum quality standards, MRM has the right to refuse work not meeting these standards, as well as, the requirements outlined below.

Jewelry Requirements: Materials made of precious metal such as gold, platinum, sterling silver or any combination of metal, and may be set with precious or semi-precious stones, as well as of stone, clay, wood, glass, leather or combination thereof, *no faux or imitations accepted*. All jewelry is original designs by the artist. All work must be new/recent (less than 1 year) since creation. *Artists will be available in the event that there is a need to make adjustments for such as sizing.*

Promotion: All jewelry that is submitted for the jewelry show may be used in promotional material including and not limited to printed materials and museum website. The contributing artist will be given credit in Advertising/Information about the event will be posted with local news media, as well as, on our website www.millicentrogers.org

Sale proceeds shall be a 35-65 Museum-Artist split. All Items in the show will remain on display and for sale at the MRM through Sunday, February 7, 2010. All sold items will be marked as sold as they sell. The artist retains ownership of any remaining items not sold. The museum will contact artist for unsold pieces that must be picked up by the artist. Artist's 65% commission checks will be available on the 15th of February 2010.

Jewelry Shipping Deposit: A \$10 shipping deposit is required to be included with your contract. This fee will be used in the event that we will have to return unsold pieces. In the event that your work sells, the \$10 will be refunded and will be included in the commission check.
